Introduction: My reflections on LIDW23



This is the first time that we have asked those who made LIDW happen to put pen to paper and reflect on the event. As the contributions flowed in, it highlighted to me that there is no better way to encapsulate LIDW23 than asking those who were there. As the week of 15 May recedes into the collective memories of the international dispute resolution community and planning for LIDW24 gains momentum, with this collection of reflections, the organising committee of LIDW23 would like to take you back briefly to that sunny week in London when we all came together and listened, debated, ate, drank, and made new friends and connections.

LIDW23 was the 4th edition of London International Disputes Week and celebrated not only all that is good about London as a centre for dispute resolution, but also reminded us how important face-to-face interaction is in the post Covid world. The event brought together 4,000 (virtual and in person) members of the international dispute resolution community, drawn from 43 jurisdictions. International Arbitration Day, hosted collaboratively across three law firms provided a focus for the international arbitration community and, the over 80 Member Hosted Events provided something for everyone. From art disputes to crypto insolvency with LIDW participants showing great stamina as those who turned up a bit late at the final event of the (long) week found out, as extra chairs had to be located! Our LIDW evenings provided some special moments too: from the spectacular Royal Courts of Justice drinks reception through the YAYAH/Law Rocks evening, which is fast becoming a favourite feature of the Week, to our in-demand gala dinner at the Dorchester-all memorable both for those of us who practise in London, and for our international visitors.

But none of this would have been possible without the hard work and input of the LIDW Members and the 2023 Organising Committee. A tremendous amount of time is spent in the planning and execution of LIDW, and its all done by busy people giving up their time voluntarily, recognising the importance of the event to London, those who live and work here, and those from overseas who use it as a hub for dispute resolution. We have also been fortunate to have as our sponsors a committed and dedicated group of organisations. 

Herbert Smith Freehills is a proud Founding Member of London International Disputes Week. In 2023, LIDW featured a dedicated International Arbitration Day for the first time: a flagship arbitration event showcasing the importance of London as a global arbitration centre. We were delighted that Herbert Smith Freehills was one of three LIDW members hosting panel events; we welcomed over 350 guests across the day – a record for our London office.

Reflecting the overall theme of “Adapting to a Changing World”, my keynote speech highlighted a new trend - “Challenging arbitral awards through the backdoor: Mitigating the increasing trend of claims against arbitrators”. Disgruntled parties unhappy with the result of their arbitration are becoming ever more creative in finding ways to overturn awards. An emerging tactic is for these parties to launch a civil action in state courts directly against arbitrators and/or against arbitral institutions, alleging bad faith or breach of public policy as a means of seeking to avoid arbitrator immunity provisions and claiming compensation.

It is impossible for any arbitrator or institution to prevent a disgruntled party from trying their luck, but the LIDW Arbitration Day enabled members of the arbitral community to consider this concerning trend and to discuss steps that can be taken to uphold immunity against meritless claims.


Insights gained from collaborating with LIDW:


